

Assuntuck Community College (ACC) encourages students to electronically apply for student financial aid. We hope to improve our services to students and assist you in completing the financial aid process.



Please be aware that ACC will not be able to determine your Financial Aid eligibility until you have a valid NetID and are accepted in an Associates degree or an eligible certificate program. Once you have completed the admissions process, you will receive a student email account and all communication from the ACC Financial Aid Office will be sent exclusively to this account.



It is important that you create a FSA ID username and password. You can establish FSA ID electronically by going to <u>FSAID.ed.gov</u>. We recommend that you create your FSA ID directly from the FAFSA website (See Step 3). If you have forgotten your FSA ID, you may click on "Forgot Username [or] Password" on the FAFSA website.



To apply for financial aid, you will need to visit the FAFSA on the Web (www.fafsa.ed.gov) site for the application. You will need personal information documents to complete the electronic application.

What do I need to fill out the FAFSA?

You will need records for income received in the year prior to the academic year you plan to attend. You may also need records of your parent(s)' income information. You will/may need:

- □ Your name as it appears on your Social Security card
- □ Your driver's license, if applicable
- W-2 Forms or other records of income earned
- Your (and your spouse's, if you are married) Federal Income Tax Return, if filed
- Records of untaxed income received such as veteran's non-education benefits, workers' compensation, and military or clergy allowances
- Current bank statements and records of stocks, bonds, and other investments, if applicable
- **D** Business or farm records, if applicable
- Your alien registration card (if you are not a U.S. citizen)

On the FAFSA, you must enter ACC's School Code Number. Enter 011150 to ensure your application information is provided to ACC.



The Student Information System

Now that you have applied for financial aid from the U.S. Department of Education and Asnuntuck Community College, you can track your financial aid application and award information online by using the Asnuntuck' s myCommNet information system

(http://my.commnet.edu). To use this system, you need to know your NetID (This password is different from your U.S. Department of Education FSA ID mentioned earlier.) When you applied for admission to Asnuntuck Community College, you were given your NetID. Your initial password is the first three characters of your birth month (the first letter capitalized), the "&" symbol and the last 4 digits of your social security number (for example: Oct&6789). If you have trouble logging in, click the "Trouble Logging In?" link in the myCommNet Login box.

In addition to being able to track your application financial aid on myCommNet, you will be able to download any documents you may need complete your application to requirements. You can then print out these documents and either mail or drop them off at the financial aid office. We will periodically email you and direct you to visit the myCommNet system to check your list of missing documents.



When we complete our review of your financial aid application, we will notify you via your student email address and direct you to the myCommNet student information system. You will be able to view your Financial Aid Award and make decisions about your awards from this site. Grants (free money) for which you are eligible will automatically be accepted on your behalf, but there may be additional awards (student loans or work-study funds) that you have the option to accept or decline.

By using myCommNet, you can review and adjust your financial aid awards, complete award requirements, and email the financial aid office with your questions and concerns. Your use of the student information system allows you 24 hours a day, 7 days a week, access to the Financial Aid Office of Asnuntuck Community College.

The purpose of this instruction sheet is to provide you with the necessary information you need to successfully complete the financial aid application process. All awards are based on full-time and adjusted to reflect the students' enrollment. Application materials cannot be accepted after the student's last date of attendance.
