Notes & Data Glossary

Report Sources and Information	The weekly preliminary credit enrollment and census reports draw from the SWKRXF02 and SWRKXF05 Banner extracts for current and prior year enrollment data, the Argos Financial Aid student extract for student financial aid data and the TWRKXF23 Banner extract for student accounts data. Current enrollment is compared to snapshots of enrollment from an appropriate date from the prior year. Prior year modality data and student balance data are not currently available for prior year comparison. For more information, contact your local institutional research professional.
% Change vs. Prior Year	The difference between the current year number and the prior year number, divided by the prior year number
Account Status	Total student tuition and fees due as of upcoming, current and previous terms, less payments, installment plan agreements, and other related authorizations
Additional Students Enrolled	Total headcount of students taking classes at a campus other than their home campus
Enrollment Level	Students taking 12 or more credits are full-time students; all other students are part-time students.
Fill Rate	Maximum section enrollment divided by current enrollment of all sections offered
Full Time Equivalents (FTE)	Total credit hours divided by 15
Home Campus Headcount	Total number of students designating (or assigned to) their home campus
Modality	Instructional method of classes that students have registered for: Students taking only LRON (live remote and online) and ONLN (fully online) sections are classified as "All Remote;" students taking OLCR (online with class component) LRCR (live remote or on ground), HYBR (online and classroom), or FLEX sections, or taking any combination of fully online, partially online, or in-person classes are classified as "Some Remote;" all other students are classified as "All in-Person."
